Youth and Young Adult Services Committee Meeting Minutes - 2/9/22

Hampden County Youth Program Update:

- 197 YYA served in the first half of this fiscal year, with 17 transitioning into stable housing
- MHA PSH full
- Gandara joint TH-RRH full
- ID'd 5 YYA for open CHD RRH slots
- 87 YYA on BNL. Case conferencing bi-weekly to match YYA to appropriate services
- In the process of bringing on fifth Navigator for 24/7 Coordinated Entry Hotline to focus on more intensive case management
- Reconvened YHDP Executive Committee to work on action plan for the next 2 grant years. We spent the first year focused on getting new housing slots filled. Time to also prioritize goals around ed/emp, health & well-being, & permanent connections so that the YYA we've housed will be able to continue supporting themselves after RRH ends.
- Next quarterly YHDP Education Cohort convening is on 3/8 and will focus on high school students & job readiness
- Youth Action Board interviewed and selected 2 new YAB Executive Committee members
- Upcoming joint YAB meeting with Three County in which YYA will learn about legislative advocacy from Pamela Schwartz & decide if they want to move forward with training in the process
- State funded college pilot btwn Holyoke Community College, Westfield State, and Gandara had 2 YYA transition to their own apartments. One YYA has moved into the dorms and one more is being identified.
- State Foster Youth to Independence pilot currently leased up 1 YYA and requesting additional vouchers for 3 more YYA who have completed the initial paperwork. 2 more YYA recently referred. Bi-weekly meeting between providers, SHA, and DCF to assess progress and needs
- Point In Time Count coming up 2/23
- State Youth Count gearing up for April

Other Hampden County Updates:

Brighter Futures Youth Shelter has done amazing work providing emergency shelter during inclement weather – stretching to be open, a fantastic team.

More general observations: experiencing the complexities of the rapid rehousing resource. Some young adults are best suited for transitional housing – not needing PSH, but also not yet ready to be entirely independent. Also experiencing both the pluses and minuses of shared living arrangements – sometimes great companionship; other times difficult to place to young adult strangers together.

Three County YHDP Update

- 4 housing projects, 3 providers, covers 36 beds across the continuum, RRH, PSH, TH
- HMIS has migrated to a new system (called Clarity)
- Also using a new Coordinated Entry tool that incorporates the changes recommended by the CE Work Group
- Youth coordinated entry group meets weekly to review the by-names list (60 youth on it): 32 enrolled, 16 housed
- YYA committee meets monthly.
- Conducting youth surveys 19 in so far exploring their experience looking at youth surveys identifying their experience with the CE system
- The YAB meets weekly participating in Point in Time count planning meetings, revising the forms to count based on a broader definition than HUD's (which does not count couch surfing or doubled-up). The CoC will pull out HUD's definition for submission to HUD but rely on the broader definition for community analysis.
- The Three County CoC is participating in a statewide review of the coordinated entry system with a racial equity lens. The YAB has stepped up to participate in the listening session for this analysis.
- Continued hardship in finding apartments.
- The CoC is hiring a homelessness services coordinator for coordinated entry and a hiring an intake and referral specialist. Go to CoC website for more info.

EOHHS funds update via DIAL/SELF;

- 160 young people are working with EOHHS across a couple of providers
- Finding apartments continues to be the most difficult challenge in Franklin/Hampshire county more apartments are coming on line but rents are much higher.

Shout-out to coordination between YHDP partners across the region CoC hiring a homeless services coordinator for CE; hiring an intake and referral specialist

Question from UMass regarding how to access services. Phil will follow-up and coordinate a meeting with all providers and UMass.

Housing development: EOHHS funds are being utilized to conduct a feasibility study regarding purchase and development of a home in North Adams – roughly 3 new RRH units, 3 new SRO-style emergency shelter units and 1 or 2 bedrooms units for small families. Approx. \$800,000 cost. Very early stage but VERY hopeful!

Announcement: Way Finders is hiring a young adult employment specialist.

FY23 Budget Update: The Governor released his proposed FY23 budget last week. The Governor's Budget includes \$80 million for RAFT, which advocates immediately recognize will not be sufficient to meet the extraordinary demand as federal funds are depleted. The statewide advocacy request is likely to be \$250 million. The Network Steering Committee is meeting next week on its FY23 budget priorities and will bring these to our next meeting on 3/8. (and be sure you are subscribed to the Network blog to stay connected to related actions!).

Legislation Update: The Joint Rule 10 day was 2/2 - the date by which legislative committees needed to determine next steps of its bills - reported out favorably, extended, or "sent to study" (which means not in play for the remainder of this legislative session). See here for a quick snapshot of the Network priority bills and how they fared. Much more advocacy to come!

Announcement: The new Executive Director of the US Interagency Council on Homelessness is Jeff Olivet, a person this region knows very well as he has consulted with our two CoC's and trained many of our partners around racial equity work over these past 3 years.
