Shelter Updates

CHD: uptick in census - 80-85% at capacity; seeing an increase in COVID cases (5 positives among families and some staff); also seeing a movement in housing placements.

Way Finders: also seeing an uptick in referrals; seeing increase in covid positives in families and staff; also seeing some more housing placements. Still facing challenges using vouchers - too few rentals, too high rent. Also DV BSAS referrals are coming in more frequently - getting support via HomeBASE.

New England Farm Workers: no new covid cases in last 3-4 weeks. All available units are occupied. Placements are variable - large families are more challenging to house. **Valley Opportunity Council:** uptick in covid cases - seeing high in-flow of families with DV

Rental assistance:

Way Finders report for Hampden/Hampshire Counties: In April: assisted over 4,400 households with \$8.6 million. Year to date assisted over 15,000 households with \$7 million. Wrapping up ERAP applications (ended on 4/15), down to 54 ERAP applications. In terms of RAFT applications as of 4/16, about 1,200 applications to date. Averaging about 90 applications/day. Still at about a 3 week processing time. Seeing homeowners who are not eligible for HAF and over-income for fuel assistance. RAFT denials are happening with maxed out due to end of ERAP and more restrictions (RAFT capped at \$7,000; no more than one month stipend - ERAP had no cap and could provide up to 3 months).

FY23 Budget Update: The budget is currently being debated by the Senate. We are advocating for key amendments. Go <u>here</u> to see the summary.
