Springfield's HOME-ARP Plan: Gerry McCafferty requested feedback to inform Springfield's HOME-ARP plan (roughly \$6 million in city funding to address housing and homelessness services). Asked for feedback on current gaps and needs. Comments included:

- EHVs are helpful but not enough, even with increases in HomeBASE
- lack of public transportation
- lack of affordable apartments
- lack of high school diploma/HISET to gain sufficient employment to obtain housing stability
- lack of sufficient mental health services
- lack of support services in general
- increasing number of DV survivors in need of housing
- lack of permanent supportive housing for DV survivors
- lack of handicap accessible housing

Shelter updates:

- DHCD has asked shelters to bring online all covid set-aside units to expand capacity.
- Noting increase in number of Haitian Creole families without citizenship status. Unable to work without documentation (wanting to work!) so required to stay in shelters for longer. Re-housing is extremely difficult.
- Landlords are refusing vouchers
- Mental health services especially difficult to obtain for undocumented clients; not enough support services!
- Noted huge increase in utility shut-offs

• Noted increase of individuals calling for shelter

RAFT/eviction prevention: In June, Way Finders served 3,363 households, averaging 90-100 applications/day. Continuing to see a large number of utility shut-offs, esp a large number of homeowners that are not eligible for HAF. There has been a reduction in staff, which could require a longer application lag time (up from current average of 3 weeks).

Network Updates:

- The FY23 Budget is still in Conference Committee and is expected to be released soon!
- The Economic Development Bill is coming up for debate and will be a vehicle for trying to push through important legislative priorities. See <u>this blog post</u> for more details.
