Career Services Meeting Minutes – January 19, 2023

This was our first meeting since May, 2022 – we had decided to take a hiatus and reconvene when useful. That time is now, with the passage of the Cliff Effect bill and the onset of the new two-year state Legislative Session.

Our discussion included:

- Congratulations on the passage of the Cliff Effect bill, which was included in the Legislature's final economic development bill adopted in July. It passed after 6 years of advocacy under the leadership of SpringfieldWorks and the Economic Pathways Coalition (amazing work!). The bill is a pilot project for 100 families (statewide) to address the "cliff" that occurs when employment occurs, income rises and public benefits get reduced, leaving the family farther behind. Currently, implementation details are in process. We will all stay tuned.
- In general, SpringfieldWorks is working on developing strategic approaches for better connecting individuals to training programs and quality jobs with the potential for advancement. Partnering with large employers to connect people to their training programs.
- Holyoke Community College reported that it is continuing to obtain new resources to develop new training programs, e.g., phelobtomy, EKG tech and more. Funding also includes support for ancillary needs such as child care and transportation.
- The Franklin County Opioid Task Force received funding for an initiative to serve 40 individuals who are in recovery and in need of employment; GCC is partnering with the Franklin County Dept. of Correction, the North Quabbin Recovery Center and the Task Force itself. GCC will be accepting referrals in the coming weeks.
- Way Finders is continuing with its workforce development programs, working closely
 with MassHires and the community colleges. They have started a new program to
 support clients in the post-employment phase. Over the last quarter, Way Finders placed
 25 clients in employment and 15 participants reached over 30 days of job retention (and
 WF continues to provide follow-up support over a 2-year period).
