Jennifer is the supervisor of the DPH Low-Threshold Housing Program and joined us to share more information about the program. Please see her <u>Powerpoint presentation here</u>.

Background info:

- This program was developed a few years ago, initially in direct response to the Mass & Cass crisis in Boston.
- The initial procurement was for Boston only, funded at \$1 million for 30 units to house a total of 60 people. The rate is roughly \$40,000 per person per year (to address complex needs and intensive case management).
- Since the success of that initial procurement, it has become a rolling, statewide procurement with a now \$10 million line-item to support the effort. BSAS is committed to its continuity.

Program goals, structure and criteria:

- The goal is to reduce homelessness, improve health outcomes and advance health equity.
- The program is structured to allow for flexible funding so that programs can meet individuals where they are at and address a broad range of barriers to housing. Beds are held if/when individuals enter treatment.
- The criteria: individuals experiencing homelessness (broadly defined, not subject to HUD definition, but among the most vulnerable) with substance use or co-occurring mental health disorders, living with HIV or do not qualify for or drop off other pathways to supportive housing.

Current Scope of Program, Impact:

• DPH/BSAS currently has 14 contracts statewide for low threshold housing and services.

people at a time while they're looking for permanent housing.

- In total in the last few years DPH has contracted for 770 units; mostly permanent and 156 temporary. There have been over 400 placements thus far and on track to house over 500 individuals by the end of next fiscal year.
- In western MA thus far, we have 195 funded LTH units and have housed 168

Coordinating with CoCs:

- LTH programs may use their local coordinated entry programs but are not required to do so. DPH encourages communication and coordination to the extent possible.
- The vulnerability index is flexible so that unique needs can be met. This program seeks to meet the needs of people who frequently don't "check the boxes" (e.g., people with sex offense histories).
- Our group noted the value of integrating the LTH data with HMIS so the region can track impact of rehousing effort across the CoC. There will be follow-up with Jennifer on this point.
