Family homelessness update

- Over 1,000 families in motels across the state. CHD: 116 families; ServiceNet: 45 families; VOC; 81 families; then without providers: Pittsfield (Hilton Garden Inn): 15 families; Great Barrington: (Quality Inn) 15 families; Hadley (Knights Inn CHD waiting to be assigned as provider)
- Family shelter beds are full all over the region.
- Waiting on the Legislature to act on the Administration's proposed \$250 million supplemental budget to fund the EA system negotiations happening between House and Senate versions House budget requires \$50 million to be allocated to overflow shelter; Senate version provides complete discretion to Administration. Vote should take place before the end of Wed. 11/15 (note: that did not happen the Legislature could not resolve differences; now in "informal session" which means must get unanimous consent this could be challenging)
- Providers discussed the challenge of shelter unit turnover state requirement to get all repairs done within 7 days (or lose payment) while it can be difficult to find contractors and get the job done.

RAFT Update:

The volume continues to be high in all 4 counties.

Hampden/Hampshire data (Way Finders): over the last 7 weeks, 700 applications have been processed. Seeing roughly 140 people per day in their lobbies. Utilities moratorium begins 11/15 - seeing shut-offs and staff are working hard to resolve them (as long as application is in by 11/15, can be addressed). Seeing a high number of moving requests. Franklin County (FCRHRA) is seeing the same thing along with high numbers of applications.

State Legislative Update

• Today the Joint Housing Committee is holding a hearing on the local option for rent control and the Tenant Opportunity to Purchase Act. The Network is providing testimony on both bills. • The Healey Administration filed the Housing Bond Bill last month, which includes \$4.1 billion in housing investments and extensive policy proposals - very exciting for meaningful investment and change. Policy proposals include the transfer fee for affordable housing, eviction record sealing and the allowance of accessory dwelling units as a matter of right. This is the very start of a lengthy process - there will be multiiple legislative hearings - and it will be key for us to get involved (amendments are needed, e.g., the transfer fee threshold is too high - home sales over \$1million - to be useful for western MA).
