All shelters are full and winter expansion is in operation. Updates include:

- Holyoke/Providence Ministries pop-up shelter is offering a "reverse 911" number to inform people when the shelter is open. Contact City Hall - Alicia Zoeller at zoellera@holyoke.org to get on the list.
- Craig's Doors has expanded its shelter at the Econolodge 58 people are staying there now; 28 at the church; 6 in overflow at each site, all full. 23 people are currently being sheltered through hotel funds.
- Friends of the Homeless Springfield has expanded from 175 to 189 beds.
- Medical Respite in Northampton has one bed available (as of 1/21)

Network Budget and Legislative Priorities Discussion

Pamela sought feedback to inform the <u>Network Steering Committee's</u> decision making around the Network's FY26 budget priorities and legislative priorities.

Previous small group and committee discussions were shared, which had prioritized for budget:

- Mass Rental Voucher Program (MRVP)
- RAFT
- Individual and family shelter

- Permanent Supportive Housing
- Unaccompanied Homeless Youth
- Alternative Housing Voucher Program (for people with disabilities) (AHVP)

And for legislation priorities had included:

- Preventing the criminalization of homelessness
- Rent Control
- Access to Counsel
- Tenant Opportunity to Purchase Act
- Real Estate Transfer Fee for Affordable Housing

This Committee responded positively to all of the previously stated priorities and added or underscored:

- ensuring adequate funding for winter weather (and if/when state funds are made available to do with adequate time to respond)
- housing for people with disabilities (AHVP)
- permanent supportive housing both in budget and legislation
- supported legislative priorities listed above
