## Family Services Committee Meeting Minutes - 5/13/25

## **Shelter Updates:**

- CHD: closing hotels Northampton site is closed; West Springfield is down to 4 families, will be closed by end of May. Using HomeBASE to great effect (landlords like it for its payment security).
- VOC: hotel closing by 6/30, down to 20 families (previously at 90)

## **General comments across providers:**

- With the rapid rehousing of so many families, the challenge increases around stabilization services. The ratio of case worker to families is 1 to 80 in many instances and "best case" is 1 to 50. Case workers are working extremely hard and there are simply not enough of them to give families the support they need to stabilize further and increase their chances of avoiding the "cliff" when HomeBASE runs out (which may be sooner than intended due to families' need to use HB to pay a higher proportion of their rent due to lack of income)
- Seeing a decrease in referrals from HLC and a resulting increase in empty units in congregate/scattered site shelter not getting filled by HLC despite hearing of families who are sleeping in their car or otherwise experiencing homelessness this is consistent with the Gov's goal to get the number of families in the system down to 4,000 (will be at roughly 5,300 once all hotels closed).

**Federal Budget Update:** President Trump released an initial federal budget for next fiscal year that would dramatically cut HUD - Section 8, and other crucial housing programs - by as much as 44%. This budget is a very first step in a long budget process (i.e., no cause for panic, but cause for alarm and activism). The Network is in close connection with the National Low Income Housing Coalition which is a source for analysis and action steps. The City of Boston joined a lawsuit to challenge restrictions on federal CoC funding. A temporary restraining order was granted and now the case proceeds with these requirements on pause. Read more at the <u>blog post here</u>.
